- Accompanied and unaccompanied shopping, social support and engagement with travel is inclusive of the worker time, fuel and travel expenses.
- Royal Freemasons pricing is applicable to all services, regardless of vendor. Where the vendor price exceeds the Royal Freemason listed price, the Vendor price + 10% administration fee will apply.
- Half hourly services will be charged at 75 per cent of the hourly rate.
- Care management fees are capped at 10 per cent of the Support at Home classification you receive.
- POA is dependent upon the agreed charges with the vendor and, in the case of consumables, dependent upon the consumable being purchased.
- Royal Freemasons will charge up to 15 per cent of the quoted cost of home modifications or \$1,500 (whichever is lower) to cover the costs of coordinating home modifications.
- Royal Freemasons will charge up to 10 per cent of the quoted cost of assistive technology or up to \$500 (whichever is lower) to cover the administrative costs of coordinating assistive technology.
- We require 24 hours' notice to cancel services without incurring the scheduling service fee charged to your Support at Home package.
- Services not listed for other Support at Home services, including assistive technology equipment and home modifications, will be agreed with your care partner, as required.
- Pricing is exclusive of GST
